

In terms of section 21 of the Correctional Matters Amendment Act, 2011 (Act No 5 of 2011), I hereby determine 1 March 2012 as the date on which all the sections of the said Act shall come into operation, except section 9 which only comes into operation with regard to sections 46, 47, 49, 49A, 49B, 49C, 49D, and 49F of the principal act, Correctional Services Act, 1998, (Act No. 111 of 1998).


