

CERTIFICATION OF HALAAL PRODUCTS

It is a condition of the bid that an **original or a certified copy** of BD 7-form (Halaal Certificate) or Certification of Halaal Compliance must be submitted with his/her bid for all halaal products.

Only certificates issued by the following Halaal Certification Bodies will be accepted:

- Muslim Prison Board
- Muslim Judicial Council
- Islamic Council of South Africa
- SANHA
- National Independent Halaal Trust

Such a certificate must be as follows:

- Should delivery take place from the premises of the bidder, the certificate should be from the bidder's premises;
- Should the bidder not normally keep the items in stock and will be sourcing the items from a third party, the certificate should be for the premises from where delivery will take place.

Bids that are not accompanied by a certificate will be disregarded.
